

**NOTE :**

1. The Judicial Officer shall hold physical hearing in their respective court rooms on the dates mentioned in the Roster while the others continue to hold courts through video-conferencing, as per the existing arrangement, on non-physical days. The Addl. Sessions Judge, who holds the physical hearing on the given day shall also deal with fresh bail applications in those cases, where



- investigation is pending and the counsel has made a specific request for hearing the matter in physical court in addition to his regular board.
2. On physical hearing days, the Court shall, wherever possible, permit hybrid/video conferencing hearing where a request to such effect is made by any of the parties and/or their counsel.
  3. All the Judicial Officer shall endeavour to take up stay applications, bail applications and other miscellaneous urgent matters on physical days, wherever request to such effect is made.
  4. The earlier direction issued by the Hon'ble High Court of Delhi vide Order No. 256/RG/DHC/2021 dated 08.04.2021 that no adverse orders shall be passed by the District Courts in case of non-appearance of parties and/or their counsel stands withdrawn w.e.f. 24.08.2021
  5. If any Magistrate is not available due to any reason, other Magistrate shall look his/her work as per the roster prepared by CMM (East).
  6. Reliever Magistrates shall work under the directions of CMM (East).
  7. The Advocates, Litigants and other visitors to the Court Complex are directed to strictly adhere to the norms of social distancing and all other Covid-19 protocols, guidelines, directions, etc. issued by the Central/State Government and Hon'ble High Court of Delhi, New Delhi from time to time.
  8. In order to restrict the footfall, only those litigants shall be allowed entry into the Courtroom(s) whose appearance is recommended by their respective counsel or who are appearing in person or whose presence has been directed by the Court.
