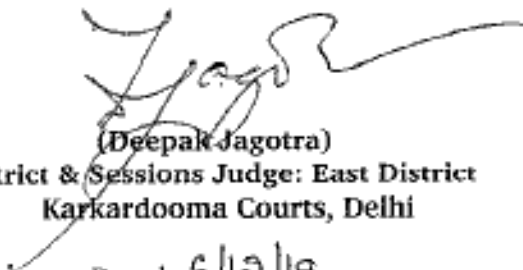


**OFFICE OF THE DISTRICT & SESSIONS JUDGE: EAST DISTRICT

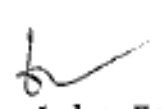
