ORDER

In continuation of this Office Orders bearing numbers 4267-4287/Judl. Br./East/KKD/Delhi, dated 30.06.2020 & 3856-3876/Judl. Br./East/KKD/Delhi, dated 14.06.2020, and in compliance of Office Order No. 24/DHC/2020 Dated 13.07.2020 of the Hon'ble High Court of Delhi, the suspended functioning of the Courts of East District, shall stand extended till 31.07.2020.
