## OFFICE OF THE CHIEF METROPOLITAN MAGISTRATE : EAST DISTRICT SESSIONS DIVISION KARKARDOOMA COURTS : DELHI ORDER

In compliance with orders no.16/DHC/2020, Dated: 13.06.2020, and no. 17/DHC/2020 Dated 14.06.2020, of Hon'ble High Court of Delhi, it is hereby directed that w.e.f. 16.06.2020, all the courts of Magistrates in East District Sessions Division, Karkardooma Courts Complex, Delhi, shall take up urgent cases (except where evidence is to be recorded) of their respective Courts through Video Conferencing mode, while adhering to the Delhi Video Conferencing Rules, 2020, framed by Hon'ble High Court of Delhi.

## It is further directed that:

- 1. Each Ld. Magistrate, East District Sessions Division, Delhi, on working days, shall hear and pass orders in all the regular bail application/s, superdari application/s, etc., which pertain to the police stations falling under the Jurisdiction of the Court presided over by such Ld. Magistrate.
- 2. However, if any bail application is allowed by any Ld. Magistrate, as abovesaid, the bail bond/surety bond would be furnished to the Ld. Duty Magistrate, East District Sessions Division, who shall pass necessary order/s thereon.
- 3. Ld. Duty Magistrate, East District Sessions Division, Delhi, on a working day, shall, apart from taking the cases pertaining to his Court, shall also hear and decide surrender application/s which pertain to any PS falling within the Jurisdiction of East District Sessions Division, Delhi. The Ld. Duty Magistrates shall look after the work of extending Judicial Custody remand of UTPs via VC, Recording 'Section 164 Cr.P.C' Statements in the Vulnerable Witness Deposition Room, Conducting Inquest Proceedings, Hearing and deciding application for transit remand of an accused, and Dealing with other urgent applications.
- 4. Ld. Duty MM shall also look after the work related to the Court of LD. CMM, East.
- 5. The Ld. Duty MM shall also look after the work of Traffic MM (Except work related to Virtual Court), for the month of June-2020 and shall deal with impounded vehicles only on the day of such duty.
- 6. It is directed that all applications and replies would be sent to the Court Email ID/Court ID before 2:00 p.m. everyday. Every Court would have a dedicated Court Email ID, list whereof is at ANNEXURE A.

- 7. The Court ID would be handled from the Court Point by the Coordinator, who shall be a staff member(s) designated by each Court
- 8. Each Ld. Magistrate shall digitally sign order/s passed by him. Otherwise, they would be manually signed and scanned, and sent.
- 9. Orders would continue to be uploaded on the District Court website server.
- 10. Bail Orders would additionally be also sent to the concerned Jail Superintendent at the Official Jail Dak ID and/or to the Coordinator of Remote Point at Jail.
