- The Judicial Officer shall hold physical hearing in their respective court rooms on the date mentioned in the Roster and rest of days they shall hold virtual hearing from their chamber/homes. However, the Duty Magistrates, and Bail ASJ Courts shall continue as it is.
- It shall be sole discretion of Judicial Officer concerned to decide as to whether a matter shall be taken up through Video Conferencing or through physical hearing or to be adjourned depending upon the facts and circumstances of each case and the number of cases fixed for physical hearing on a given day.
- 3. If any Magistrate is not available due to any circumstances, other Magistrate shall look his / her work as per the roster prepared by Ld. CMM (East).
- 4. Reliever Magistrates shall look his/her work under directions of Ld. CMM (East).
- 5. The Judicial Officer shall ensure that on the day when they hold physical court, the causelist of their respective court shall be session wise, in the sense that it shall specify which cases shall be taken up in first session (from 10.30 AM to 12.30 PM) and which cases shall be taken up second session (from 2.00 PM to 3.30 PM).
- 6. On days other than the above mentioned physical courts days, every Judicial Officer shall hold court through videoconferencing, taking up the entire causelist of that day of her / his court.
- All concerned shall ensure adherence to the Standard Operating Protocol (SOP) issued in August 2020, already circulated among the Judicial Officers, Staff as well as the Bar.
