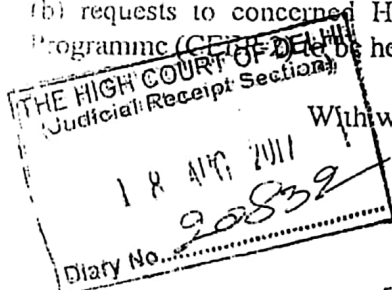
Sub.: Regarding Nominations for NJA Programmes for the academic year 2017-18 from September, 2017 to May, 2018.

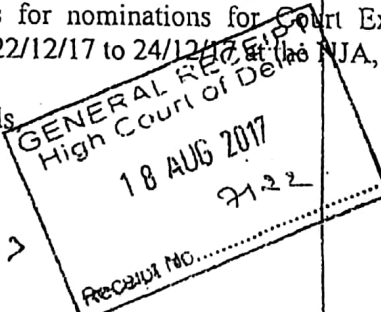
