Shyam Singh, Reader/Judicial Assistant on 29.06.2020 are also advised to isolate/self-quarantine themselves for 7 days w.e.f. 29.06.2020. They are further directed to closely monitor their health and take all necessary precautions as per the advisory/guidelines issued by Government of India.
