Appointment of Special Metropolitan Magistrates/Spl.Municipal Magistrates (Littering)

Fresh applications are invited for appointment as Special Metropolitan Magistrates/Special Municipal Magistrates (Littering) under Section 18(1) Cr.P.C. These Magistrates will be required to hold court 6 days in a week either at a fixed place or as mobile court.

The candidates must possess the qualification as prescribed in Rule 3 of Delhi Petty Offences (Trial by Special Metropolitan Magistrate) Rules, 1998 which reads as under:-

- "3. Qualification:- A person shall not be qualified for appointment as Special Metropolitan Magistrate unless he/she is a law graduate and:-
 - (1) has been a District Magistrate or a Judicial Officer; or
 - (2) has for a period of not less than one year exercised the powers of Sub Divisional Magistrate; or
 - (3) has for a period of not less than two years exercised the powers of an Executive Magistrate; or
 - (4) has held for a period of not less than five years a Group 'A' post on the Establishment of the High Court of Delhi or that of the Courts Subordinate thereto; or
 - (5) has held, for a period of not less than five years, a Group 'A' post under the department of the Government of NCT of Delhi or the Central Government or State Government (Preference will be given to those persons who have been dealing with legal affairs or have been working in the department dealing with legal affairs); and
 - (6) has not attained the age of 65 years on the date of conferment of power of Special Metropolitan Magistrate on him/her.

Explanation : - For the purpose of these rules a "law graduate" is a person who is eligible to be enrolled as an advocate."

Government servants who were dismissed or removed or retired compulsorily from service or subjected to any other penalty for misconduct etc. are not eligible for consideration.

At present there are 35 vacancies and the appointments shall be made in respect of the existing and anticipated vacancies that may arise during the year. A Special Metropolitan Magistrate/Special Municipal Magistrate (Littering) shall be entitled to the following honorarium and out of pocket expenses or as may be fixed by the High Court from time to time:-

Out-of-pocket expenses: Rs.35,000/- (per month),

Transport allowance: Rs.7 500/- (per month),

Dress allowance: Rs.12,000/- (per annum).

Application in the prescribed form (attached herewith), duly filled in along with passport size photograph duly attested by a gazetted officer affixed thereon, attested copies of requisite documents i.e., date of birth certificate, LLB Degree and Retirement Certificate, may be submitted in the Establishment Branch, Administrative Block, Delhi High Court, New Delhi or sent by registered AD post to the Registrar General, Delhi High Court, New Delhi 110503, so as to reach on or before 30.03.2019.

Applications which are incomplete, unsigned without requisite documents and received after the due date shall be rejected summarily and no enquiry will be entertained in this regard. Only eligible and short listed candidates will be called for an interview, if any, on a date to be intimated later and no TA/DA shall be paid to the candidates for the purpose.
