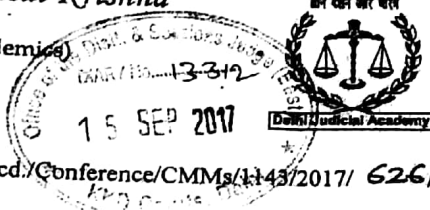


It is requested that the nominated Judicial Officers posted in your District may kindly be communicated the programme schedule and schedule of their participation through your good office.
