

**C I R C U L A R**

In case, PRO/APRO is on leave or not available for any reason, Judicial Branch, East District (Office No: 011-22101427) shall look after the above said work.

The Judicial Branch, East District, Karkardooma Courts, Delhi shall inform/update the P.R.O./A.P.R.O regarding availability of Judicial Officers against recorded delivery.


