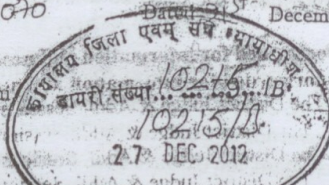

Sub: - Sanction for reimbursement of 50% of minimum wages for unskilled category for engagement of Peon-cum-Home Orderlies for judicial Officers for their residential Camp Office facility.

Madam,

I am directed to convey the approval / sanction of Govt. of NCT of Delhi for extending the benefit of reimbursement of 50% of minimum wages for two (2) Peon-cum-Orderlies to the senior officers of Delhi Higher Judicial Service who are in the scale of Rs.67,000-79,000 and above (i.e. HAG and above) and one (1) Peon-cum-Orderly to the officers of Delhi Higher Judicial Service / Delhi Judicial Service who are in the pay scale of PB-3: Rs.15,600-39,100 + Grade Pay Rs.7600/- and above at their residential Camp Office facility w.e.f. 01.02.2011 at the minimum wages rate prevailing on the aforesaid date, subject to further revision applicable from the date of such revision for minimum wages for unskilled worker by Govt. of NCT.

Further, the Finance Department has also advised that the department may obtain a certificate from the Judicial Officer concerned "That He / She has employed Peon-cum-Orderly w.e.f.01.02.2011" before processing the claim for reimbursement.

This issues with the concurrence of the Finance Department, Govt. of NCT of Delhi vide their U.O. No.492/DS2 dated 20/12/2012.
