All the Judicial Officers are also requested to personally supervise the aspect related to updation by checking the status online through ecourts.gov.in/services and National Judicial Data Grid (NJDG) ecourts.gov.in/services/njdg/index.php and to send certificate regarding complete updation along with monthly statement (s) on regular basis.

All the concerned staff officials under their respective control may also be conveyed that delayed updation of case-information on NJDG would invite strict disciplinary action.
