ORDER



1. The Judicial Officer shall hold physical hearing in their respective court rooms on the date mentioned in the Roster and rest of days they shall hold virtual hearing from their chamber/homes. However, the Duty Magistrates, and Bail ASJ Courts shall continue as it is.
2. It shall be sole discretion of Judicial Officer concerned to decide as to whether a matter shall be taken up through Video Conferencing or through physical hearing or to be adjourned depending upon the facts and circumstances of each case and the number of cases fixed for physical hearing on a given day.
3. In order to avoid over-crowding, the Undertrial Prisoners shall continue to be produced through Video Conferencing only.
