**CIRCULAR**

In order to properly maintain record of decided bail applications and smooth functioning of Courts/Bail Section of East District, the following practice shall be adopted with immediate effect:-

- (i) The Bail Section (East) shall send all the decided bail applications lying in the bail section since 2021 including bail applications/anticipatory bail applications/any other bail applications alongwith the orders to the concerned Courts of MM's including Mahila Courts having jurisdiction over the concerned Police Station.
- (ii) The practice of consigning the decided bail/ anticipatory bail applications/any other bail applications to the Record Room by the Bail Section discontinues forthwith.
- (iii) All the Ahlmads/Assistant Ahlmads of the concerned Metropolitan Magistrate shall attach such bail applications with the chargesheet, If the case is committed to Sessions Courts than the Ahlmad/Assistant Ahlmad of the concerned MM Court will send the Bail Application to the Concerned Sessions Court.

Non-compliance of the aforesaid directions shall be viewed seriously.
