CJM Office/Senior Civil Judge, East District shall keep record of the work done by the Relieving JMFC/Civil Judges, respectively posted in East District and shall forward the same to this office for onward transmission to Hon'ble High Court of Delhi, New Delhi on quarterly basis or till they get regular posting whichever is earlier.

The staff of Transferor Court will send the files/records/proceedings to the Transferee Court in all respects with instructions to the Parties or other concerned/witnesses/applicants to appear before the Transferee Court on the date fixed and Transferor Court would display the cases with name of Transferee Court on the Notice Board of the Court.
- 2. The Ahlmad/Asstt. Ahlmad/Nazir of the Transferor Court will handover the files/records/proceedings to the Ahlmad/Asstt. Ahlmad/Nazir of the Transferee Court, so that all kind of applications (whether C.A., Inspection etc..) may be dealt with by Transferee Court.
