ORDER

Pursuant to Order no. 38/DHC/Gaz-IIB/G-7/VI.E2(a)/2024 dated 25.10.2024 of Hon'ble High Court of Delhi, New Delhi with regard to postings/transfers of Officers of Delhi Judicial Service one New Court of JMFC (NI Act) Digital Court-02, East District has been created with immediate effect. In view of the directions contained in the above mentioned Order, all odd number cases as per list Annexure "A" received from the court of JMFC(NI Act), Digital Court -01 shall be assigned to the newly created Court of JMFC(NI Act), Digital Court -02 and Even number cases shall remain with JMFC(NI Act), Digital Court-01 of East District as per list annexure "A", for disposal in accordance with Law, with immediate effect.

Notes:

1. The staff of Transferor Court will send the files/records/proceedings to the Transferee Court in all respects with instructions to the Parties or other concerned/witnesses/applicants to appear before the Transferee Court on the date fixed and Transferor Court would display the cases with name of Transferee Court on the Notice Board of the Court.
2. The Ahlmad/Asstt. Ahlmad/Nazir of the Transferor Court will handover the files/records/proceedings to the Ahlmad/Asstt. Ahlmad/Nazir of the Transferee Court, so that all kind of applications (whether C.A., Inspection etc.) may be dealt with by Transferee Court. **The connected/cross case/applications be also transferred alongwith main case files.**
