Sub:- Directions for Private foreign Visits.

Pursuant to the directions contained in letter no. 1042-1055/DHC/Gaz.II-A/G-10/2025 dated 25.02.2025 and 6413-6426/DHC/Gaz.II-A/G-10/2024 dated. 13.11.2024 of Hon'ble High Court of Delhi, New Delhi on the above noted subject, it is hereby impressed upon all the Officers of Delhi Judicial Service (DJS) posted in East District to send the applications seeking permission of private foreign visit duly forwarded through Chief Judicial Magistrate (CJM) or Senior Civil Judge (SCJ), respectively, as applicable in respect of jurisdiction to this office for onward transmission to Hon'ble High Court of Delhi, New Delhi.

While forwarding the application of Officers of DJS seeking permission to visit abroad in any month, the concerned CJM or SCJ, East District will indicate the names of those DJS Officers whose such applications for the same month have already been forwarded by the quarter concerned and in case the permission to visit abroad is granted to the concerned officer, it will not cause any hardship in the distribution of his/her judicial work and no Link Court will be over burdened. The information is to be filled in the prescribed proforma given by the Hon'ble High Court of Delhi, New Delhi (copy enclosed).

Further, all the judicial officers of East District are requested to comply with the directions contained in the above said letters of Hon'ble High Court of Delhi, New Delhi. (copy enclosed).


Sir/Madam,
