As per order read as 1<sup>st</sup> paper above, Sri.Goutham. A. Anilkumar, S/o Late Indu.P, former Nyayadhikari, Gram Nyayalaya, Vellanad (Ayilyath House, Kuppadi (PO), Sulthan Bathery, Wayanad-673592 )has been appointed as Clerk in the Judicial Department (Civil Wing) of Kozhikode District under the Scheme for the Compassionate Employment of the dependents of Government servants who die in harness. The incumbent has reported before the District Judge, Kozhikode with the Certificates to prove his, age, qualification, medical fitness, character and antecedents.The certificates are verified.The incumbent is posted to **Munsiff- Magistrate Court , Payyoli** in the existing vacancy.

The certificate of medical fitness, character and antecedents and a copy of Government Order cited 1<sup>st</sup> are forwarded to the Munsiff- Magistrate , Payyoli. The Presiding Officer is directed to verify and ascertain the identity of the person and to adminster the Oath of allegiance to the Constitution before admitting the candidate to join duty.The incumbent should produce the details regarding his movable and immovable properties in the proforma as prescribed in GO(P) No. 171/16 Fin. Dated 15.11.2016 at the time of joining in service.The Presiding Officer concerned shall verify the same and the fact may be recorded and pasted in the service book of the incumbent. The date of joining duty of the incumbent shall be informed to this Court. The incumbent is informed that the application for correction of date of birth, if any, needed in his case should be made within 5 years of his entry in service and the application for correction of date of birth in Service Register shall be submitted to the Government in the



Administrative Department concerned through proper channel as envisaged in G.O. (P) No. 45/91/P&ARD, dated 30.12.1991.

The appointment is liable to be cancelled without notice, if it is found on further verification that there were misrepresentation or suppression of material facts on the part of the applicant at the time of forwarding the application or during the course of enquiry conducted by the Department , as per rules.
