As per the reference 1st above, Smt.Sheeba.W.L (PEN: 738923), Process Server, of this court has submitted a representation stating that she had not been given promotion as Office Attendant Grade-I and also she had not been given promotions to the post of Court Keeper Grade-II, Court Keeper Grade-I and Process Server in time.

On verification of the Service Register of the incumbent, it is found that she has entered in service on 17.11.2014 as Office Attendant Grade-II as per Order No. A1-11892/14 dated 13.11.2014 of the District Judge, Kozhikode and satisfactorily completed the period of probation in the post of Office Attendant Grade-II w.e.f 17.11.15. On 15.12.2015, she entered to Leave Without Allowances for 3 years under Appendix XII C, Part I, KSR. On 21.08.2018 she had rejoined in this department on expiry of the leave. Subsequently she was promoted as Court Keeper Grade-II w.e.f 01.08.2019, Court Keeper Grade-I w.e.f 06.11.2019 and Process Server w.e.f 24.12.2019. But she had not been given promotion as Office Attendant Grade- I w.e.f 17.11.2015, on the eligible date of her promotion to that post. As per the reference 2nd above, this court had regulated the date of promotions of staff in the category of Court Keeper/ Duffadar to the post of Process Server in view of G.O (MS) No. 176/2012/Home dated 06.07.2012. In the said Government Order, the scale of pay of Process Servers has been revised w.e.f 01.04.2003.

As per the above said revised promotion order Smt. Deepa.V, the next junior of the incumbent had given promotion as follows.

W.e.f 23.03.2019 as Court Keeper Grade-II.

W.e.f 06.11.2019 as Court Keeper Grade-I.

W.e.f 21.12.2019 as Process Server.

In the above circumstances, the date of promotions of the incumbent is refixed as follows.

W.e.f 17.11.15 as Office Attendant Grade-I.

W.e.f 23.03.2019 as Court Keeper Grade-II.

W.e.f 06.11.2019 as Court Keeper Grade-I.

W.e.f 21.12.2019 as Process Server.

The incumbent is entitled to get the benefits of refixation except for the period of Leave Without Allowances under Appendix XII C, Part I, KSR.
