Sri. Anil Raj.R (PEN: 964475), Office Attendant, O/o Waqf Tribunal, Kozhikode has submitted a representation requesting to relieve him from the post of Office Attendant in the Civil Judicial Department of Kozhikode District to take up new employment as Civil Excise Officer (Trainee) in Excise Department, Kozhikode District.

The incumbent has filed a declaration to the effect that no liabilities to the Government or Co-Operative institutions are outstanding against him and no disciplinary proceedings or vigilance enquiry is pending against him. He also filed an undertaking to the effect that he will not claim any lien or right in this department after his relief from the post of Office Attendant.
