**ORDER NO. A1 - 2521/2025**

**DATED : 07.03.2025**

The following order of temporary appointment of **Clerk** in the scale of pay of Rs.26,500-60,700/- advised by the Kerala Public Service Commission under Rule 9 (a)(1) of the Kerala State and Subordinate Service Rules 1958 is issued.

The instructions to be followed by the candidate is shown below:

The candidate shall produce the **Original One Time Verification Certificate/ Identification Certificate which includes the scanned image of photo and signature of the candidate ,Certificate of conduct and character** in Form No III as prescribed in G.O(P) No.156/88/Home S.S.B Department dated 12.12.1988 and a Medical certificate of fitness as prescribed in G.O.(P)No.20/2011/ P & ARD dated 30.06.2011, given by the competent authorities.

Oath of allegiance to the constitution should be administered to the candidate when they join duty. The incumbent should produce the details regarding his movable and immovable properties in the proforma as prescribed in GO(P) No.171/16 Fin. dated 15.11.2016 at the time of joining in service. The Presiding Officers concerned shall verify the same and the fact may be recorded in the service book of the incumbent . The candidate is directed to join duty within 15 days on receipt of this order, failing which his appointment will be treated as cancelled.

The Presiding Officer concerned should satisfy himself the identity and signature of the candidate with reference to the **Original One Time Verification Certificate/ Identification Certificate which includes the**

**scanned image of photo and signature of the candidate** before they are allowed to join duty. **A candidate who fails to produce Original One Time Verification Certificate/ Identification Certificate shall not be admitted to duty under any circumstances.** If there is any discrepancy, the candidate should not be allowed to join duty and the fact should be reported to this office forthwith. After the candidate is allowed to join duty, the **Original One Time Verification Certificate/ Identification Certificate** shall be forwarded to the appointing authority after recording necessary entries on the 2<sup>nd</sup> page **within 7 days** of appointment. The appointment of the candidate shall be regularised only after obtaining a verification certificate from Kerala Public Service Commission.

The presiding officer concerned is further directed to verify the identification and Community / Non Creamy Layer Certificates in respect of the candidate advised against reservation turns at the time of joining duty. The candidate is informed that in case of his discharge from service for want of vacancy, he may either register his name in the office of the Public Service Commission from where he has been advised otherwise he shall lose the right of probation in the department from where he has been discharged for want of vacancy or may wait for their turn for re- appointment to the post in the Department in case they desire to continue in the post in which they have been discharged.

The candidate is informed that his appointment shall be terminated without notice if the Department is not satisfied with the character and antecedents on subsequent verification. The advice of the candidate is subject to Rule 3 (c) of General Rules of K.S & S.S.R.

He is further informed that the application for correction of date of birth if any needed in his case should be made within 5 years of their entry in service and the application for correction of date of birth in Service Register shall be submitted to the Government in the Administrative Department concerned through proper channel as envisaged in G.O.[P].45/91 P&A RD dated 30-12-1991.
