



ORDER

In pursuance to the minutes of meeting of the Hon'ble State Court Management System Committee (SCMSC) held on 12.09.2017, the cases pending in the court of **Sh. Brijesh Kumar Garg, ADJ-01/NE**, as mentioned at **S. No. 1 to 40** as per "**Annexure-A**" are hereby withdrawn and assigned to the court of **Sh. Gorakh Nath Pandey, ADJ/PO-MACT (Pilot Court)/NE**, for disposal in accordance with law, with immediate effect.

**Notes :-**

3. If there is/are any case/s left that is/are connected with the above said cases, the same be also sent to the transferee court alongwith the main case(s). Later, if there is any connected case arises with the above said cases; thereafter, the same shall also be sent to the Court of Sh. Gorakh Nath Pandey, PO-MACT (Pilot Court)/NE, alongwith the main case(s).


