PRACTICE DIRECTION



Filing of single copies of DAK (status reports, rejoinders, replies etc.) by Parties / Advocates in criminal matters listed before a Division Bench causes serious inconvenience to the Registry.

It is therefore directed that henceforth copies of DAK (status reports, rejoinders, replies etc.) in criminal matters listed before a Division Bench be filed by Parties / Advocates in advance in duplicate. Single copies of such documents shall not be accepted.

These directions shall come into force with immediate effect.
