AWADHESH KUMAR YADAV, ADVOCATE (En. No. 825/1991 DT. 16.4.1991, AOR No. 07089), PATNA HIGH COURT

It is hereby notified for general information that the name of Shri Awadhesh Kumar Yadav, Advocate, Patna High Court (Bihar), Son of Shri Ram Nandan Prasad Yadav, resident of village Ram Nagar Diyara, P.O.-Sohan Ray Tola, P.S.-Bakhtiyarpur, District-Patna (Bihar), present address-Mohalla-Salimpur Ahra, P.O.-Kadam Kuan, P.S.-Gandhi Maidan, District-Patna (Bihar), who was enrolled on 16.4.1991 vide Enrolment No. 825/1991 (A.O.R.No. 07089) has been debarred from practicing as an Advocate by Disciplinary Committee No. II of Bihar State Bar Council by order dated 16.1.2018 passed in D.C. Enquiry No. 16/2017 on the basis of cognizance taken by Bihar State Bar Council in the light of order dated 17.5.2017 passed in Criminal Miscellaneous No. 31740/2016 (Chandan Paswan Vs. State of Bihar), Under Section 35(3)(c) of the Advocates Act, 1961. Thus Shri Awadhesh Kumar Yadav, Advocate, Patna High Court is debarred from practicing as an Advocate in any Court or before any authority or person in India, from the date of this notification, for a period of one year and if Shri Yadav will not appear personally after expiry of suspension period, he will not regain his license.
