Note :- If the Chairman of the Committee is not available due to any reason, the next senior most member of the committee shall act as Chairman.

The Digitization Committee will supervise the digitization work on day to day basis and to ensure that sufficient numbers of records/judicial files are made available to the outsourced agency to complete the project. The Committee may obtain status of scanning of record on weekly or fortnightly basis, it can check quality of scanned documents, view and supervise the scanning process randomly to avoid inferior quality of scanning and legible preservation of data in e-format.

The Digitization Committee shall sort out the problems/issues arised in the digitization work. If the problems/issues are not sort out by the Committee, the Incharge, Digitization Cell shall inform the Nodal Officer (Computers) of this district. The Nodal Officer (Computers)/NE and the Officer Incharge (Computers), Karkardooma Courts, Delhi shall sort out the problems/issues in the digitization of the record and shall report to the undersigned. In extreme circumstances, if the matter is not sorted out, then the Chairman may refer the matter to the Centralized Computer Committee through undersigned.
