CIRCULAR

In continuation of the directions issued by this Court on 13.03.2020 and 16.03.2020, Hon'ble the Chief Justice and Hon'ble Judges of this Court have been further pleased to issue the following instructions to the Delhi District Courts:-

- i. To decongest court rooms and Registry/Branches, only one Advocate per party shall be permitted entry in the court rooms and Registry/Branches.
- ii. This restriction shall not apply to Senior Advocates, who may appear before the court with a single briefing counsel.
- iii. District & Sessions Judges shall issue appropriate directions in this regard with intimation to the respective Bar Associations.
