- 3. The Courts of Civil Judge-6, Central and Civil Judge-8, Central, THC hitherto presided over by Mr. Bharat Chugh and Ms. Colette Rashmi Kujur, respectively, are abolished and the District & Sessions Judge (HC), THC shall assign the cases of their courts to other such courts so as to ensure equal pendency.
- 4. The courts of Civil Judge-10, Central and Civil Judge-11, Central, THC hitherto-presided over by Ms. Harshita Vatsayan and Mr. Vijay Kumar Jha respectively stand redesignated as Civil Judge-6, Central, THC and Civil Judge-8, Central, THC, respectively.
- 5. The Court of MM (Mahila Court)-4, South-West, Dwarka hitherto presided over by Ms. Jasjeet Kaur is abolished and the District & Sessions Judge, South-West, Dwarka shall assign the cases of her court to other such courts so as to ensure equal pendency.
- 6. The Court of MM-8. West, THC hitherto presided over by Mr. Jitendra Singh is abolished and the District & Sessions Judge, West, THC shall assign the cases of Police Stations Mundka and Khayala to the court of MM-6, West, THC presided over by Ms. Deepika Singh, the cases of Police Station Ranhola to the court of MM-4, West, THC presided over by Mr. Gajender Singh Nagar and the cases of Police Station Kirti Nagar to the court of CMM, West, THC presided over by Ms. Charu Aggarwal.
- 7. The Court of Municipal Magistrate, North, Rohini hitherto presided over by Ms. Rajani Ranga is abolished and the District & Sessions Judge, North, Rohini shall assign the cases of her court to the court of MM (Traffic), North, Rohini presided over by Mr. Anurag Dass.
