Notes:-

1. The judicial officers shall be under the control of the Principal District & Sessions Judge of the district to which they have been allocated.
2. The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.
3. The Principal District & Sessions Judge, (South) Saket, shall withdraw sufficient number of cases from the existing courts of District Judge (Commercial Court) and assign them to the newly created court of District Judge (Commercial Court)-03 and District Judge (Commercial Court)-(Digital-04) so as to ensure equal pendency.
4. The Principal District & Sessions Judge (South East) Saket shall withdraw sufficient number of cases from the existing courts of District Judge (Commercial Court) and assign them to the newly created courts of District Judge (Commercial Court)-03 to District Judge (Commercial Court)-06 and District Judge (Commercial Court) (Digital)-07, so as to ensure equal pendency.
5. The Principal District and Sessions Judge(s) South and South East Saket, shall :-
  - a. *ensure that adequate infrastructure (including IT infrastructure and infrastructure for video conferencing/ hybrid hearings) is created for such digital/ paperless Commercial Courts.*
  - b. *Each Digital Commercial Court shall, in addition to the regular staff, be provided one more official to create, update and manage the digital files.*
  - c. *Only the newly e-filed cases (filed after 01.04.2022) shall be assigned to the said Courts. However, the number of Commercial Suits assigned to the said Courts, be maintained at around 250 each.*
  - d. *The e-Filing Rules of the High Court of Delhi 2021 shall apply in respect of e-filing of pleadings, documents, records, etc. and all other incidental matters.*
  - e. *Digital files shall be maintained by the said Courts. However if any record is physically generated/ filed or original documents are directed to be filed (by the Court) they shall be kept by the Ahlmad in a physical file separately maintained case-wise and their scanned copies shall be placed in the digital file as well.*
  - f. *All orders, final judgments and decrees shall be digitally signed by the Judge.*

- g. All hearings shall be conducted mandatorily through video conferencing, though in exceptional cases, for reasons to be recorded, the Court may direct proceedings to be conducted in physical mode or hybrid mode. The Courts shall have a dedicated e-mail id and permanent VC link which shall remain active during Court working hours. However, evidence shall be recorded in physical mode or in a manner as otherwise provided under law.*
- h. All proceedings of the Court conducted through video conferencing/ hybrid mode shall be conducted as per the "High Court of Delhi Rules for Video Conferencing for Courts 2021".*
- i. Similar technical platform and IT infrastructure, as are being used in the Digital NI Act Courts, with the necessary changes, may be used for the Digital Commercial Courts.*
6. The Court of Mr. Ajay Pandey, Judge Family Court, Shahdara stands re-designated as "Additional Principal Judge, Family Court, Shahdara, KKD" while Ms. Rajrani, who is the successor court of Ms. Preeti Aggarwal Gupta, presently Additional Principal Judge, Family Court, North-West, Rohini shall be designated as Judge Family Court, North-West, Rohini.
7. The court of Judge Family Court, South-West, Dwarka presided over by Mr. Vipin Kumar Rai is henceforth re-designated as Judge Family Court-01, South-West, Dwarka.
8. The court of Judge Family Court, South-East, Saket which shall now be presided over by Ms. Smita Garg is henceforth re-designated as Judge Family Court-01, South-East, Saket and the newly created Court to be presided over by Mr. Kuldeep Narayan is designated as Judge Family Court-02, South-East, Saket.
9. The court of Judge Family Court, East, KKD presided over by Mr. Naresh Kumar Malhotra is henceforth re-designated as Judge Family Court-01, East, KKD.
10. The Court of Judge Family Court, West THC presided over by Mr. Raj Kumar Tripathi is henceforth re-designated as Judge Family Court-01, West, THC and the Court of Judge Family Court, West, THC presided over by Ms. Charu Aggarwal is henceforth re-designated as Judge Family Court-02, West, THC.
11. The concerned Principal Judge(s), Family Courts shall withdraw sufficient number of cases from the existing Family Courts of their respective districts and assign them to the newly created Family Courts in their respective districts so as to ensure equal pendency.
12. The Principal District & Sessions Judge, South, Saket shall withdraw sufficient number of cases which are more than 4 years old from the existing ASJ courts and assign them to the newly created court of ASJ (FTC)-01 and ASJ (FTC)-02, which is a Fast Track Court for trial of old criminal cases.
13. The Principal District & Sessions Judge, South-East, Saket shall withdraw sufficient number of cases which are more than 4 years old from the existing ASJ courts and assign them to the

newly created court of ASJ(FTC)-01 and ASJ (FTC)-02, which is a Fast Track Court for trial of old criminal cases.

14. The Principal District & Sessions Judge, South East, Saket shall withdraw sufficient number of Rape cases from the existing courts and assign them to the newly created court of ASJ(SC-RC) which is a special court for rape cases, so as to ensure equal pendency.


