1. The judicial officers shall be under the control of the Principal District & Sessions Judge of the district to which they have been allocated.
2. The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.
3. The court of Civil Judge, South, Saket presently presided over by Ms. Neha Sharma, is henceforth re-designated as Civil Judge-01, South, Saket.

4. The Principal District & Sessions Judge, South, Saket, shall assign sufficient number of cases to the newly created court of Civil Judge-02 on withdrawal from the existing courts, so as to ensure equal pendency.
5. The Principal District & Sessions Judge, South-East, Saket, shall assign sufficient number of cases to the newly created court of Civil Judge-03 on withdrawal from the existing courts, so as to ensure equal pendency.
6. The Principal District & Sessions Judge, Shahdara, KKD shall assign sufficient number of cases to the newly created court of Civil Judge-03 on withdrawal from the other existing courts so as to ensure equal pendency.
7. The Principal District & Sessions Judge, South, Saket, shall assign the cases of PS Mehrauli to the newly created court of MM-05, South Saket, after withdrawing the same from the court of ACMM, South, Saket.
8. The Principal District & Sessions Judge, South, Saket, shall assign the cases of PS Hauz Khas to the newly created court of MM-06, South Saket, after withdrawing the same from the court of MM-02, South, Saket.
9. The Principal District & Sessions Judge, South, Saket, shall assign sufficient number of cases to the newly created courts of MM (NI Act)-06, MM (NI Act)-07 and MM (NI Act)-08, on withdrawal from the existing courts of similar jurisdiction of the district, so as to ensure equal pendency.
10. The Principal District & Sessions Judge, South-East, Saket, shall assign the cases of PS Amar Colony to the newly created court of MM-12, South-East Saket, after withdrawing the same from the court of MM-10, South-East, Saket.
11. The Principal District & Sessions Judge, South-East, Saket, shall assign sufficient number of cases to the newly created court of MM (NI Act)-05, on withdrawal from the existing courts of similar jurisdiction of the district, so as to ensure equal pendency.


