1. The Judicial Officer shall hold physical hearing in their respective court rooms on the date mentioned in the Roster and rest of days they shall hold virtual hearing from their chambers/homes. However, the Duty Magistrates, and Bail ASJ Courts shall continue as it is.

2. Physical Hearing shall take place in two sessions 10:30am to 12:30pm and 2:00pm to 3:30pm. Causelist shall reflect the sessions in which the hearing is to take place.

3. It shall be sole discretion of Judicial Officer concerned to decide as to whether a matter shall be taken up through Video conferencing or through physical hearing or to be adjourned depending upon the facts and circumstances of each case and the number of cases fixed for physical hearing on a given day.

4. In order to avoid over-crowding, the Under Trial Prisoners shall continue to be produced through video conferencing only.

Furthermore, the Standard Operating Procedure (SOP)/guidelines for opening of entry gate/exit points, Vehicle Parking, Sanitization Desk, Medical Facilities, Dispensaries etc. shall be notified shortly.
