- 2 Physical Hearing shall take place in two sessions 10:30am to 12:30pm and 2:00pm to 3:30pm. Causelist shall reflect the sessions in which the héaring is to take place.
- 3. It shall be sole discretion of Judicial Officer concerned to decide as to whether a matter shall be taken up through Native conferencing or through physical hearing or to be adjourned depending upon—the facts and circumstances of each case and the number of cases fixed for physical hearing on a given day.
- 4. In order to avoid over-crowding, the Under Trial Prisoners shall continue to be produced through video conferencing only.
