- 3. The courts may in exceptional cases, permit any of the parties and/or their counsel to join the proceedings through video conferencing subject to availability of requisite infrastructure.
- 4. It is expected that the advocates, litigants and other visitors to the Courts strictly adhere to the norms of social distancing and all other Covid-19 protocols, guidelines, directions etc. issued by Government of India, Government of NCT of Delhi and Hon'ble High Court of Delhi, New Delhi from time to time.
