

The Judicial Officers shall hold physical hearing in their respective court rooms on the date mentioned in the Roster and rest of days they shall hold virtual hearing from their chambers/homes.

2. It is further directed that Judicial Officers shall hold regular physical courts, on a daily basis, as per regular court timing w.e.f. 15.03.2021 and shall take up all cases fixed before them. The Judicial Officers are impressed upon to take up those cases on priority, where the accused is in custody for a considerable period.

3. The courts may in exceptional cases, permit any of the parties and/or their counsel to join the proceedings through video conferencing subject to availability of requisite infrastructure.

4. It is expected that the advocates, litigants and other visitors to the Courts strictly adhere to the norms of social distancing and all other Covid-19 protocols, guidelines, directions etc. issued by Government of India, Government of NCT of Delhi and Hon'ble High Court of Delhi, New Delhi from time to time.
