1. The Metropolitan Magistrates (Reliever), mentioned in Column No 3, on the day of duty as per roster, shall look after the work of 'extending the JC remand of the UTPs to be produced from the prisons, assigned to North-East District, through VC; Conducting the TIPs of the case properties; TIP/s of the CCL/s; recording statements of the witnesses under Section 164, Cr.P.C.; Inquest proceedings; and any other administrative duties, as per Order No 71/DHC/ Gaz/G-7 NI.E.2(a)/2020 dated 18.11.2020, of the Hon 'ble High Court of Delhi, which might be assigned to them by order of the Ld. Principal District and Sessions Judge (North-East), and by the Chief Metropolitan Magistrate, North-East.
2. The Link Metropolitan Magistrate (Reliever), mentioned in Column No 4, on such day, shall work as link MM of the Court/s whose Presiding Judge(s)/Magistrate(s) is/are on leave on that day.
3. The Metropolitan Magistrates (Reliever) are advised not to take leave on the day they are assigned the duty as per roster prepared hereinabove. However, he/she may change his/her day of duty/ies on mutual exchange basis with his/her Link MM (Reliever) well in advance. If the Metropolitan Magistrate (Reliever) is not available on any day of his/her duty, due to some unavoidable reasons, then his / her link MM (Reliever) shall perform the duty in his /her place'.
