

ORDER

In pursuance to the directions of the Hon'ble High Court of Delhi, as contained in the letter no. 22577-87/Rules/DHC/2016 dated 05.12.2016 ; letter no. 23062-72/Rules/DHC/2016 dated 09.12.2016 & letter no. 23700-710/Rules/DHC/2016 dated 21.12.2016 and in terms of meetings of State Court Management System Committee (SCMSC) dated 22.11.2016 and 06.12.2016, a **Pilot Court for MACT (Special Reference to Permanent disability cases)** in North-East District has been established and functioning w.e.f. 02.01.2017 and is presided over by **Sh. Gorakh Nath Pandey, ADJ-02/NE, Court Room No. 69, 5th Floor, B-Block, Karkardooma Courts, Delhi.**

Henceforth, the claim petitions filed by the victims of road accidents **involving injury and disability (except Fatal & Untraced)**, as the case may be, and DAR filed by the police in said cases, pertaining to all police stations of North-East District, as well as case where the accidents occurred outside Delhi and where parties are claiming jurisdiction of North-East District, shall be filed in the **Court of Sh. Gorakh Nath Pandey, ADJ-02/NE, Court Room No. 69, 5th Floor, B-Block, Karkardooma Courts, Delhi being the Pilot Court for MACT/NE (Special Reference to Permanent disability cases).**

And, the claim petitions filed by the victims of road accidents **involving Fatal and Untraced**, as the case may be, and DAR filed by the police in the said cases, pertaining to all police stations of North-East District, as well as case where the accidents occurred outside Delhi and the parties are claiming jurisdiction of North-East District, shall be filed in the **Court of Ms. Kiran Bansal, PO-MACT, Court Room No. 63, 4th Floor, B-Block, Karkardooma Courts, Delhi.**

Note :- 1. However, in the cases where a Fatal case and an Injury case are both involved in the same accident, the said connected cases shall be filed in the Court of Sh. Gorakh Nath Pandey, ADJ-02/NE, Court Room No. 69, 5th Floor, B-Block, Karkardooma Courts, Delhi, being the Pilot Court for MACT/NE (Special Reference to Permanent disability cases).

2. Further, the parties are directed to clearly mention the details i.e. if DAR is already filed or not; if already filed, then to mention the Next date of hearing with the Name & Number of Court appearing, before filing it in the Filing/Facilitation Center, in the said cases.
