ORDER

In wake of the recent incident of fire at Karkardooma Courts, Delhi, as a fire safety measure, I am directed by the Principal District & Sessions Judge, East District/ Chairman Building Maintenance Committee, Karkardooma Courts, Delhi to direct all the Staff Members posted at Karkardooma Courts Complex, Delhi to ensure before leaving the office, that all the electric appliance (UPS, Computers, photocopy Machines, Air conditioners and other electrical appliances etc.) installed at their work place should be in switch 'OFF' mode. All the Judicial Officers/Officer In-charges are requested to assign the duty of switching 'OFF' the electrical equipment after office hours to one of the staff members posted in their respective Court/Branch and a register be maintained regarding the same on daily basis. The In-charge Caretaking Branches of all three Districts are directed to depute one official to ensure all the electric switches are 'OFF' before locking the premises.

All the Branch In-charges/Readers of the Branches/Courts are hereby directed to remain vigilant and ensure that no electrical appliance, installed in their respective Branch/Court is in switch 'ON' mode after office hours and in case any electrical appliance found in faulty condition the same should be brought to the notice of the respective Care Taking Branch/PWD department immediately for necessary action to avoid any untoward incident of fire.

Further, I am directed to request all the Advocates who have been allotted a chamber/seat at Karkardooma Courts, Delhi to ensure before leaving the court complex that all the electric appliances installed at their work place/chambers should be in switch 'OFF' mode and in case any electrical appliance found in faulty condition the same should be brought to the notice of the Care Taking Branch/ PWD department for necessary action without any delay.

Non-compliance of the above said directions by any staff members will be viewed seriously and strict action shall be taken again the erring officials as per rules.
