
**ORDER**

In continuation of this office earlier orders no. 6972-90/Judl./Pilot Court/N-E/KKD/Delhi/2016 dated 22.12.2016 ; no. 7118-34/Judl./Pilot Court/N-E/KKD/Delhi/2016 dated 26.12.2016 and no. 119-144/Judl./Pilot Court/N-E/KKD/Delhi/2017 dated 04.01.2017, the cases pending as per "Annexure-A" (list attached herewith) in the Court of **Ms. Kiran Bansal, PO-MACT/NE**, are hereby withdrawn and assigned to the Court of **Sh. Later, if there is any connected case arises with the above said cases; thereafter, the same shall also be sent to the Court of **Sh. Gorakh Nath Pandey, ADJ-02/PO-MACT (Pilot Court)/NE**, alongwith the main case(s).


