All the Judicial Officers are, therefore, directed "not to apply for 1 or 2 days commuted / medical / earned leave if they have more than 2 days casual leave in their account." They are also impressed upon "not to exhaust casual leave in first few months" and it should be availed in such a manner that it is spread over the whole of the calender year

Further, all the Judicial Officers posted at North-East District are directed not to apply for half day compensatory leave as the same is not admissible.
