The judicial officers shall be under the control of the Principal District & Sessions Judge of the district to which they have been allocated.

The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.

The court of District Judge (Commercial Court), East, KKD presided over by Mr. Sanjay Sharma-I is henceforth re-designated as District Judge (Commercial Court)-01, East, KKD.

The court of District Judge (Commercial Court), South-West, Dwarka presided over by Mr. Pankaj Gupta is henceforth re-designated as District Judge (Commercial Court)-01, South-West, Dwarka.

The Principal District & Sessions Judge(HQ), Central, THC shall withdraw sufficient number of cases from the existing courts of District Judge (Commercial Court) and assign them to the newly created court of District Judge (Commercial Court)-07 so as to ensure equal pendency.

6. The Principal District & Sessions Judge, East, KKD shall withdraw sufficient number of cases from the existing court of District Judge (Commercial Court) and assign them to the newly created court of District Judge (Commercial Court)-02 so as to ensure equal pendency.

7. The Principal District & Sessions Judge, Shahdara, KKD shall withdraw sufficient number of cases from the existing courts of District Judge (Commercial Court) and assign them to the newly created courts of District Judge (Commercial Court)-03 and District Judge (Commercial Court)-04 so as to ensure equal pendency.

8. The Court of Ms. Preeti Aggarwal Gupta, Judge Family Court, North-West stands re-designated as "Additional Principal Judge, Family Court, North-West, Rohini" while Ms. Charu Aggarwal, who is the successor court of Ms. Illa Rawat, presently Additional Principal Judge, Family Court shall be designated as Judge, Family Court, West, Tis Hazari Court.

9. The Principal District & Sessions Judge, East, KKD shall withdraw sufficient number of rape cases from the existing courts and assign them to the newly created courts of ASJ(SC-RC)-01 and ASJ(SC-RC)-02 which are special courts for rape cases, so as to ensure equal pendency.

10. The Principal District & Sessions Judge, East, KKD shall withdraw sufficient number of POCSO cases from the existing courts and assign them to the newly created court of ASJ(SC-POCSO) which is a special court for POCSO cases, so as to ensure equal pendency.
11. The Principal District & Sessions Judge, North-East, KKD shall withdraw sufficient number of POCSO cases from the existing courts and assign them to the newly created court of ASJ(SC-POCSO) which is a special court for POCSO cases, so as to ensure equal pendency.
12. The Principal District & Sessions Judge, Shahdara, KKD shall withdraw sufficient number of POCSO cases from the existing courts and assign them to the newly created court of ASJ(SC-POCSO) which is a special court for POCSO cases, so as to ensure equal pendency.
13. The Principal District & Sessions Judge, South-West, Dwarka shall withdraw sufficient number of cases from the existing court of District Judge (Commercial Court) and assign them to the newly created courts of District Judge (Commercial Court)-02 and District Judge (Commercial Court)-03 so as to ensure equal pendency.
14. The Principal District & Sessions Judge, South-West, Dwarka shall withdraw sufficient number of cases which are more than 4 years old from the existing ASJ courts and assign them to the newly created court of ASJ(FTC) which is a Fast Track Court for trial of old criminal cases.
15. Chairman (I.T. & Digitization), Delhi District Courts shall look after the work of Centralized Computer Committee as well as Digitization pertaining to all the District Courts. He shall have his office and shall operate from RACC.
16. Mr. Ashutosh Kumar who has proceeded on medical leave shall remain attached to the office of Principal District & Sessions Judge (HQ) and shall be assigned work as and when he rejoins office.


