ORDER

Consequent upon the Order of the Hon'ble High Court of Delhi, bearing no. 60/DHC/Gaz/G-1/VI.E.2(a)/2019 dated 05th December, 2019, a new court of District Judge (Commercial Court), North-East District has been constituted. Notes :-

Ahlmad/Nazir of the Transferor Court is directed to send the files/records/proceedings to the Transferee Court in all respects immediately, with the instructions to the Parties or other concerned/witness/applicants to appear before the Transferee Court on the date fixed and Transferor Court would display the cases with the name of Transferee Court on the Notice Board of the Court, so that no inconvenience is caused to the Lawyers and litigants.
3. If there is/are any case/s left that is/are connected with the above said cases, the same be also sent to the transferee court alongwith the main case(s). Later, if there is any connected case arises with the above said cases; thereafter, the same shall also be sent to the Court of Sh. Laxmi Kant Gaur, District Judge (Commercial Court)/NE, alongwith the main case(s).
