
ORDER

In pursuance to the directions of the Hon'ble High Court of Delhi, as contained in the letter no. 22577-87/Rules/DHC/2016 dated 05.12.2016 ; letter no. 23062-72/Rules/DHC/2016 dated 09.12.2016 & letter no. 23700-710/Rules/DHC/2016 and in terms of meetings of State Court Management System Committee (SCMSC) dated 22.11.2016 and 06.12.2016, for establishing a **Pilot Court for MACT (Special Reference to Permanent disability cases) in North-East District w.e.f. 02.01.2017 and to be presided over by Sh. Gorakh Nath Pandey, ADJ-02/NE**, the cases pending in the Court of Ms. Kiran Bansal, PO-MACT/NE, as per list "Annexure-A" and "Annexure-B" attached herewith, are hereby withdrawn and assigned to the Court of Sh. Gorakh Nath Pandey, ADJ-02/NE, being a Pilot Court in this district to be functioning from 02.01.2017, for disposal in accordance with law, with immediate effect.

Notes :- 1. The Presiding Officer of the transferor court shall notify transferred cases in the cause list. The transferor court shall also convey to the litigants/Advocates of case notified for the Pilot Court that their case shall be taken up by Pilot Court for the same purpose on that day itself.

2. Ahmad/Nazir of the Transferor Court is directed to send the files/records/proceedings to the Transferee Court in all respects immediately, with the instructions to the Parties or other concerned/witness/applicants to appear before the Transferee Court on the date fixed and Transferor Court would display the cases with the name of Transferee Court on the Notice Board of the Court, so that no inconvenience is caused to the Lawyers and litigants.

3. If there is any case connected with the above said cases same be also sent to the transferee court alongwith the main case(s).


