

Sub: Constitution of Review Sub-Committee to improve disposals and for expediting adjudication.


Dear Sir/Madam,

I am directed to inform you that Hon'ble the Acting Chief Justice, in order to provide a platform to the Judicial Officers to express their vision as well as difficulties to enable systematic improvements in disposals and for expediting adjudication, has been pleased to direct that each District shall have a Sub-Committee of Judicial Officers called "Review Sub-Committee". The said Sub-Committee shall be headed by a Senior Judicial Officer posted in the same jurisdiction to strategize and deliberate upon disposal of cases with special attention to monitoring cases. The aim and object of the Committee is to creation of leadership and peer groups amongst Judicial Officers.


It has further been directed that the members of the Committee shall be appointed on three monthly rotational basis. The Sub-Committee should meet regularly, say, once in a week and the Review Sub-Committees will send a monthly report to the Disposal Review Committee of the Delhi High Court.

You are therefore requested to put into place "Review Sub-Committee" in your respective Districts with the overall objective of improving disposals and adjudication. Compliance report may kindly be sent with seven days for perusal of Hon'ble the Acting Chief Justice.
