Sub: Matters pertaining to the Delhi Rent Control Act, 1958, during the suspended functioning of courts till 23.05.2020.

In compliance of directions given by Hon'ble High Court of Delhi, New Delhi vide office order bearing no. R-305/RG/DHC/2020 dated 21.05.2020, the following Judicial Officers of North-East District shall look after the urgent matters relating to applications seeking leave to contest/defend under the Delhi Rent Control Act, 1958, as per the schedule state below:

1. The urgency of the matters shall be decided by the Judicial Officer on duty that day.
2. The hearing of such cases, shall only be conducted through video conferencing including CISCO WebEx.

4. The Ld. Counsels appearing for both the sides, are hereby impressed upon to send brief written submissions through e-mail. Each court shall have its independent e-mail ID for the said purpose which shall be suitably notified.
5. It is further directed that no adverse order shall be passed by the concerned courts without giving hearing through video conferencing or without having written submission from the concerned Ld. Counsels.
6. It is further directed that necessary precautions and crucial norms of social distancing be strictly adhered to in the course of proceedings and to ensure that there is no crowding in the corridors and other areas of the court complex.
7. The Judicial Officer on duty are directed to ensure to call only those staff officials for their assistance not more than one-third on the date of their duty who are residing in Delhi and are using own conveyance with intimation to office of the District & Sessions Judge, North-East District, Karkardooma Courts, Delhi.
