In view of the order No 71/DHC/Gaz/G-7/VI.E.2(a)/2020 dated 18.11.2020 of the Hon'ble High Court of Delhi, the following Duty/Link Roster of the MMs (Reliever), posted in the North East District and Sessions Division, is made with immediate effect for the working days during month of March 2021 (from 15th to 31st March), till further orders.

NOTE:

The Metropolitan Magistrates (Reliever), mentioned in Column No 3, on the day of duty as per roster, shall work as link MM of the Court's whose Presiding Judge(s)/Magistrate(s) is/are on leave on that day. They shall record statements of the witnesses under Section 164, Cr.P.C. They shall also perform any other administrative duties, as per Order No \(\frac{1}{1}\text{DHC}/\text{Gaz}/\text{G-7}\text{NI.E.2(a)}\) 2020 dated 18.11.2020, of the Hon ble High Court of Delhi, which might be assigned to them by order of the Ld. Principal District and Sessions Judge (North-East), and by the Chief Metropolitan Magistrate, North-East. The applications for TIPs of the accused and the case properties etc. shall also be made to them.

The Link Metropolitan Magistrale (Reliever), mentioned in Column No 4, on such day, shall look after the work of 'extending the JC remand of the UTPs to be produced from the prisons through VC'. In case, they are available in the Court Complex, they shall also record statements of witnesses under Section 164, the Cr.P.C. Any other work can also be assigned to them by order of CMM/ACMM North-East on such days.

2. 17, 19, 22, 26, 27, 30, 31

The Metropolitan Magistrates (Religver), mentioned in Column No 3, on the day of duty as per roster shall entertain applications for TIPs of the accused. In case the TIP is required to be conducted in prison, such proceedings shall be conducted by the Ld. MMs on a day when their names are mentioned in column no. 4. In any case, they shall not leave the Court complex for jails before 2.30

If the Metropolitan Magistrate (Reliever) is not available on any day of his/her duty due to some unavoidable reasons, then his /her link MM (Reliever) shall perform the duty in his /her place. If both of them are on leave on a particular day, or not available for some unavoidable reasons, the Duty MM of the day shall look after the work of 'extending the JC remand of the UTPs to be produced from the prisons through VC. Remaining duties shall be performed as per the link roster of the Ld. Magistrates. North East District.
