CIRCULAR

This is in continuation to this office earlier circular no. 26719-269499/CZ/Comp./2024 dated 04/05/2024 regarding installation of All-In-One DELL Optiplex 7410 Computer Systems received through Hon'ble High Court of Delhi under eCourts Project exclusively for Delhi District Courts.


It has been brought to the notice that the official/users are not cooperating with the official of Computer Branch and Engineers deputed by the OEM/Supplier for installation of All-In-One Computer Systems thereby causing hurdle in completion of installation.

Considering the same and to complete the installation process at the earliest, all concerned officials are directed to adhere to the following instructions:

1. Receive the All-In-One Computer Systems within three days positively from the Computer Branch/Computer Store of respective court complex against proper receipt and record (One for Judicial Officer, for VC, One for Reader and One for each Stenographer posted in the respective court).
2. The data back-up of existing Computer Desktop System is sole responsibility of the concerned user/official. The Computer Branch or Technical Team of OEM/Supplier will not be responsible for loss of any data during installation process.
3. The concerned official shall co-operate with the team of Computer Branch and Technical Team of OEM/Supplier of AIOs and remain present till completion of installation process.
4. The stock of existing/replaced Computer Desktop Systems be kept by the user, till further orders.
5. The Readers of all the Courts functioning in all court complexes are directed to submit a compliance report regarding installation of All-In-One Computer Systems to their respective Computer Branch Complex, within a week.

Non-compliance of the aforesaid directions shall be viewed seriously.


