3. The successful bidder shall deposit 25% of the bid value on the acceptance of bid in cash as per rule 220(iv) of GFR-2017.

That the total auction price will be deposited by the qualified bidder within three working days (excluding bank holiday) from the date of auction in the shape of demand draft drawn in favour of the **Principal District & Sessions Judge (New Delhi District)**, Patiala House Court, New Delhi. In case of default, the deposit of 25% amount shall stand forfeited.
5. The condemned articles will be removed after deposit of payments positively from the court premises at 10 a.m. on 10.11.2024.


