On receipt of report of the said Committee, further disciplinary action/proceedings against the erring employee shall be initiated in view of the provisions contained in Haryana Civil Services (Punishment and Appeal) Rules, 2016, Haryana Civil Services (Government Employee Conduct) Rules, 2016 and the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013.
