**NOTIFICATION**

The Hon'ble High Court of Karnataka vide Notification No.GOB.II.63(1) dated 09.04.2025 has modified the Judicial functioning of the Court of Civil Judge & JMFC, K.R. Puram, as per which only civil cases to be conducted in the Court of Civil Judge and JMFC, K.R. Puram and the criminal cases pertaining to the jurisdiction of the Civil Judge and JMFC, K.R. Puram to be withdrawn from the said Court and shall be transferred to the jurisdiction of Junior Division Courts at Bengaluru Rural District where they were tried earlier.

In view of the above, in modification of this office notification of even number dated 27.03.2025, only the civil cases pending before the Courts of Civil Judge, Bengaluru Rural District, Bengaluru pertaining to the jurisdiction of Bengaluru East Taluk comprising Revenue Circles of Varthur, Bidarahalli and K.R. Puram, be transferred to the Court of Civil Judge & JMFC, Krishnarajapuram.

Further, the criminal cases pending before the courts of Chief Judicial Magistrate, Bengaluru Rural District, Bengaluru pertaining to the jurisdiction of Bengaluru East Taluk comprising Revenue Circles of Varthur, Bidarahalli and K.R. Puram be retained and tried in the said courts. If any criminal cases are already transferred to the court of

Civil Judge & JMFC, Krishnarajapuram same be re-transferred to the concerned courts of Chief Judicial Magistrate, Bengaluru Rural District, Bengaluru.

The Advocates and parties may be instructed to appear before the concerned Court on the next date of hearing.
