For Empanelment of Advocates as Panel Lawyers for District Legal Services Authority, Dhule and Taluka Legal Services Committee, Shirpur/ Sakri/ Shindkheda/ Dondaicha.

Applications are hereby invited from eligible Advocates for empanelment as Panel Lawyers for the District Legal Services Authority, Dhule and Taluka Legal Services Committee, Shirpur/ Sakri/ Shindkheda/ Dondaicha to provide legal aid and assistance to eligible beneficiaries under the Legal Services Authorities Act, 1987 and the relevant Regulations.

### **1. Eligibility Criteria:**

- A) The applicant must be duly enrolled with the Bar Council.
- B) The applicant must have a minimum of three years' experience at the Bar.
- C) The applicant should possess sound knowledge and experience in handling cases before District and Taluka Courts.
- D) The applicant must have good professional standing, integrity, and competence.
- E) Preference may be given to advocates having experience in specific fields such as **Criminal Law, Civil Law, Family/Matrimonial matters, Labour Law, Juvenile Justice, POCSO, Motor Accident Claims, Domestic Violence cases, etc.**

### **2. Documents to be Submitted:**

Applicants shall submit the following documents along with the application:

- A) Duly filled prescribed application form.
- B) Self-attested copy of Sanad/Enrollment Certificate.
- C) Certificate of practice/experience from Bar Association.
- D) Details of experience with special reference to types of cases handled.
- E) Aadhaar Card copy.
- F) Recent passport-size photographs.
- G) Any other supporting documents (if applicable).

### **3. Tenure and Honorarium:**

The panel shall ordinarily remain valid for a period of three years, subject to review as per rules. Honorarium and fees shall be payable as per the Rules/Regulations framed by the National Legal Services Authority (NALSA) and Maharashtra State Legal Services Authority (MSLSA), as amended from time to time.

**4. Mode of Selection:**

- A) Applications received shall be scrutinized.
- B) Eligible candidates may be called for interaction/interview.
- C) Final selection shall be subject to approval by the Competent Authority.

**5. Last Date for Submission:**

Applications must reach the office of District Legal Services Authority, Dhule **on or before 24/02/2026 during office hours by hand/Speed post/RPAD.**

Applications received after the due date shall not be considered.
