ORDER

Consequent upon transfer and posting of Civil Judges (Junior Division) from and at Gurugram as conveyed by the Hon'ble High Court through endorsement number 355 Gaz.I/VI.M.46 dated 28.05.2024 and in the light of instructions contained in letter number 213 Spl.Gaz.II/IX.C.11 dated 02.04.2014 of the Hon'ble High Court (qua heavy pendency of cases under Negotiable Instruments Act,1881) it is ordered as under:

- A. Mohammad Imtiyaj Khan, Civil Judge (Junior Division), Gurugram [who has been posted at Gurugram as an Additional Officer] shall deal with entire pendency of cases which was hitherto dealt with by the Court of Shri Saurabh Sharma, the then Civil Judge (Junior Division), Gurugram. The Officer shall hold Court in Court Room Number 7A.
- B. Ms. Jyoti Grover, Civil Judge (Junior Division), Gurugram [who has been posted at Gurugram vice Ms. Aashima Garg, Civil Judge] shall deal with entire pendency of cases of her own Court as well of the Courts of Shri Hari Kishan and Shri Varun Bansal, Civil Judges (Junior Division), Gurugram. The entire pendency of cases of the Courts of Shri Hari Kishan and Shri Varun Bansal shall stand transferred to the Court of Ms. Jyoti Grover. Ms. Jyoti Grover shall hold Court in Court Room Number 11 on 3rd Floor of Labour Court Building which was occupied by Ms. Aashima Garg.
- C. Ms. Nidhi Beniwal, Civil Judge (Junior Division), Gurugram [who has been posted at Gurugram vice Shri Mandeep Singh, Civil Judge] shall deal with entire pendency of cases of her own Court as well as of the Court Shri Akash Jindal, Civil Judge (Junior Division), Gurugram. The entire pendency of cases

of the Court of Shri Akash Jindal shall stand transferred to the Court of Ms. Nidhi Beniwal. Ms. Nidhi Beniwal shall hold Court in Court Room Number 03 on 2nd Floor of Labour Court Building which was occupied by Shri Mandeep Singh.

- D. Shri Mukesh Kumar, Civil Judge (Junior Division), Gurugram [who has been posted at Gurugram vice Shri Akshay Kumar] shall deal with entire pendency of cases of his own Court as well as of the Court of Shri Vikas Yadav, Civil Judge (Junior Division), Gurugram. The entire pendency of the cases of the Court of Shri Vikas Yadav shall stand transferred to the Court of Shri Mukesh Kumar. Shri Mukesh Kumar shall hold Court in Court Room Number 17 on 3rd Floor of Labour Court Building which was occupied by Shri Akshay Kumar.
- E. Ms. Rupam, Civil Judge (Junior Division), Gurugram [who has been posted at Gurugram as an Additional Officer] shall deal with entire pendency of cases which was hitherto dealt with by the Court of Shri Azad Singh, the then Civil Judge (Junior Division), Gurugram. Ms. Rupam shall hold Court in the Court Room Number 09 on 2nd Floor of Labour Court Building, which was occupied by Shri Azad Singh.
- F. Shri Abhishek Chaudhary, Civil Judge (Junior Division), Gurugram [presently dealing with the cases under Negotiable Instruments Act,1881] shall now deal with the entire pendency of cases which was hitherto dealt with by the Court of Shri Sunil Kumar, the then Civil Judge (Junior Division), Gurugram. Shri Abhishek Chaudhary shall hold Court in Court Room Number 22 in Main Building, which was occupied by Shri Sunil Kumar.
- G. Shri Vikas Yadav, Civil Judge (Junior Division), Gurugram [presently dealing with regular cases] shall now exclusively deal with cases under Negotiable Instruments Act, 1881 pending in the Court of Shri Abhishek Chaudhary, Civil Judge (Junior Division),

Gurugram. The entire pendency of cases of the Court of Shri Abhishek Chaudhary shall stand transferred to the Court of Shri Vikas Yadav. Shri Vikas Yadav shall hold Court in Court Room Number 13 on 3rd Floor of Labour Court Building, which was occupied by Shri Abhishek Chaudhary.

- Shri Varun Bansal, Civil Judge (Junior Division), H. Gurugram shall now exclusively deal with cases under Negotiable Instruments Act, 1881 mentioned at serial number 01 to 400, 801 to 1200, 1601 to 2000, 2401 to 2800, 3201 to 3600 and so on (after a gap of 400 cases) upto 27600 and from 28001 to 28100 of the list Annexure-'A'. The said cases shall stand withdrawn from the Court of Ms. Priya Gupta, Judicial Magistrate First Class, Gurugram and transferred to the Court of Shri Varun Bansal, for disposal in accordance with law. Similarly, the cases mentioned at serial number 1 to 200, 601 to 800, 1201 to 1400, 1801 to 2000, 2401 to 2600, 3001 to 3200, 3601 to 3800, 4201 to 4400, 4801 to 5000, 5401 to 5600, 6001 to 6200, 9901 to 10000 and from 12901 to 13000 of the list Annexure-'B'. The said cases shall stand withdrawn from the Court of Ms. Seema-I, Judicial Magistrate First Class, Gurugram and transferred to the Court of Shri Varun Bansal, for disposal in accordance with law. Shri Varun Bansal shall hold Court in Court Room Number 06 on 2nd Floor of Labour Court Building, which is otherwise also presently held by him.
- Shri Hari Kishan, Civil Judge (Junior Division), Gurugram shall now exclusively deal with cases under Negotiable Instruments Act, 1881 mentioned at serial number 1 to 400, 951 to 1350, 1901 to 2300, 2851 to 3250, 3801 to 4200 and so on after a gap of 550 cases upto 25100 and serial number 25651 to 25850 of the list Annexure-'C'. The said cases shall stand withdrawn from the Court of Shri Sumit Turkiya, Judicial Magistrate First Class and transferred to the Court of Shri Hari Kishan, for disposal in accordance with law. Similarly, the cases mentioned at serial number 1 to 400, 1501 to 1900, 3001 to 3400,4501 to

4900, 6001 to 6400 and so on after a gap of 1100 cases upto 18400 and from serial number 19501 to 19800 of the list **Annexure-'D'**. The said cases shall stand withdrawn from the Court of Shri Abhishek Chaudhary, Judicial Magistrate First Class, Gurugram and transferred to the Court of Shri Hari Kishan, for disposal in accordance with law. Shri Hari Kishan shall hold Court in Court Room Number 07 on 2nd Floor of Labour Court Building, which is otherwise also presently held by him.

Shri Akash Jindal, Civil Judge (Junior Division), J. Gurugram shall now exclusively deal with cases under Negotiable Instruments Act, 1881 mentioned at serial number 19801 to 20200, 20601 to 21000 and 21401 to 21900 of the list Annexure-'D'. The said cases shall stand withdrawn from the Court of Shri Abhishek Chaudhary, Judicial Magistrate First Class, Gurugram and transferred to the Court of Shri Akash Jindal, for disposal in accordance with law. Similarly, the cases mentioned at serial number 1 to 400, 3701 to 4100, 7401 to 7800,11101 to 11500 and 14801 to 15200 of the list Annexure-E. The said cases shall stand withdrawn from the Court of Ms.Shweta Sharma, Judicial Magistrate First Class, Gurugram and transferred to the Court of Shri Akash Jindal, for disposal in accordance with law. Similarly, the cases mentioned at serial number 1 to 400, 1601 to 2000, 3201 to 3600, 4801 to 5200, 6401 to 6800, 8001 to 8400, 9601 to 10000, 11201 to 11600, 12801 to 13200, 14401 to 14800 and 16001 to 16200 of the list Annexure-F. The said cases shall stand withdrawn from the Court of Shri Amit Ahlawat, Class, Gurugram Judicial Magistrate First transferred to the Court of Shri Akash Jindal, for disposal in accordance with law. Similarly, the cases mentioned at serial number 1 to 400, 1001 to 1400, 2001 to 2400, 3001 to 3400, 4001 to 4400 and so on (after a gap of 600 cases) upto 21400 and serial number from 22001 to 22200 of the list Annexure-G. The said cases shall stand withdrawn from the Court of Ms. Sonia, Judicial Magistrate First Class, Gurugram and transferred to the Court of Shri Akash Jindal, for disposal in accordance with law.

Akash Jindal shall hold Court in Court Room Number 16 on 3rd Floor of Labour Court Building, which is otherwise also presently held by him.
